This year's theme – Stepping Up – enables us to focus on the parts of the system that fail people experiencing disadvantage and imprisonment. It is an invitation to think through how communities and systems might change, or 'step up' to better support people returning from prison.

The Reintegration Puzzle Conference brings together advocates, practitioners, researchers and others interested in reducing the cycle of disadvantage and imprisonment. We focus on the lived experience of people who have been in the justice system, drawing from that experience to drive ideas for change.

The national conference provides an opportunity to hear the latest information concerning innovations, programs and services which support people to reintegrate after prison. There is an emphasis on supports that are evidence based or effective in reducing recidivism.

The Reintegration Puzzle Conference is run as a low budget, cost recovery event. We aim to keep our delegate costs low so that staff from NGOs and advocates for people with lived experience of prison can attend. Our sponsorship package encourages organisations to make an early commitment to register their staff (at the earlybird rate) to attend the conference in return for acknowledgement as a conference sponsor.
